

# **Take Action**



Senate Bill 25 - legislation that allows CRNPs to practice independently and eliminates the requirement that they collaborate with physicians - was recently re-introduced.

CRNPs are already beginning to contact their Senators in large numbers to support their independent practice. The physician voice needs to be heard loud and clear to protect quality patient care and patient safety in Pennsylvania.

Between now and March 20, the Pennsylvania Medical Society (PAMED) encourages Pennsylvania physicians to schedule an appointment with their Senator while they are in their home districts to discuss this bill and express their opposition.

Though it's preferable for you to set up a face-to-face meeting with your Senator, you can also send them an email or call them using PAMED's online grassroots action tool. If you are sending an email, we strongly encourage you to customize the email and share your own stories, experiences, and perspective related to why SB 25 should be opposed.

PAMED continues to strongly oppose this bill, and supports a physician-led, team-based approach to care. Physician-led, team-based care emphasizes increased coordination and integration among providers, rather than provider autonomy. Eliminating the collaborative tie that currently exists between CRNPs and physicians is contrary to these proven concepts and would only serve to further fragment patient care and jeopardize patient safety.

# VICTORY: ANTHEM-CIGNA MERGER BLOCKED BY COURT

In a significant win for organized medicine and the nation's patients, federal judge Amy Berman Jackson blocked the proposed Anthem-Cigna merger. The judge found that the merger would have substantially lessened competition for the sale of health insurance to national employers resulting in higher prices and diminished prospects for innovation. In a historic, stunning affirmation of the position urged by the AMA and consequently adopted by the government, Judge Jackson concluded that an enhanced ability to coerce physicians to accept lower reimbursement is not a merger efficiency defense. She determined that it would not benefit consumers and "would erode the relationship between insurers and providers" and "reduce the collaboration" that is essential to innovation in payment and delivery.

The decision affirms the position urged by AMA and the 17-state medical association antitrust coalition members, particularly our partners in CA, CO, CT, GA, FL, IN, ME, MO, NY, OH, and VA. The AMA/coalition position was adopted in the plaintiffs' complaint, and the judge rejected the insurers' arguments that lowered physician reimbursement would benefit consumers and justify the merger.

The AMA and its coalition partners worked tirelessly to oppose this merger: updating our gold standard Competition in Health Insurance: A Comprehensive Study of U.S. Markets; preparing detailed market analyses specific to the proposed Anthem-Cigna merger; sending comprehensive, evidence-based advocacy letters to the US Department of Justice (DOJ) and state regulators after the merger was announced in July 2015; engaging like-minded stakeholders like the American Hospital Association and various patient coalitions, as well as the National Association of Attorneys General; conducting extensive physician surveys to gauge physician concern about the merger and presenting the DOJ and state regulators with compelling survey results; testifying in or submitting memoranda in various state insurance department hearings and/or attorney general investigations, and making that, and other evidence and testimony, available to the DOJ and state regulators; securing outside experts to buttress our arguments and strip down those of the insurers -- all demonstrating how the merger would harm patients and physicians.

This victory is the result of our relentless, focused and collaborative advocacy. We want to take this opportunity to thank all of our coalition partners for helping us achieve this historic victory on behalf of our physician members and their patients. The impact of blocking both mega-mergers cannot be overstated. Our collective work on both mergers is, without a doubt, a model for future advocacy success.

# PA.'S LAW ON PRESCRIBING OPIOIDS TO MINORS: AN IMPORTANT UPDATE FOR PRESCRIBERS

Pennsylvania's law on prescribing opioids to minors—Act 125 of 2016—was signed by Govenor Wolf on Nov. 2, 2016. The law stipulates that, except for specified exceptions, a prescriber:

- May not prescribe more than a seven-day supply of an opioid to a minor if a parent or guardian signs the form on behalf of the minor authorizing the prescribing of the opioid; or
- Is limited to no more than a single, 72-hour supply of an opioid to a minor if an authorized adult (other than a parent or guardian) signs the form on behalf of the minor authorizing the prescribing of the opioid. In addition, when an authorized adult is present instead of a parent or guardian, the prescriber is required to indicate on the prescription the quantity that is to be dispensed pursuant to that prescription.

Pennsylvania's state licensing boards were required to create the consent form that prescribers need in order to fully comply with the law. Physicians and other prescribers should be aware that the consent form was published in the *Pennsylvania Bulletin* on Feb. 4, 2017, and is now available online.

The form requires details such as the name of the medication, quantity, amount of initial dose, and number of refills. It also requires the prescriber to certify that he/she has discussed the following items with both the minor and the minor's parent/guardian/authorized adult:

- The risks of addiction and overdose associated with the controlled substance containing an opioid.
- The increased risk of addiction to controlled substances to individuals suffering from mental or substance use disorders.
- The dangers of taking a controlled substance containing an opioid with benzodiazepines, alcohol or other central nervous system depressants.
- Any other information in the patient counseling information section of the labeling for controlled substances containing an opioid that is deemed necessary.

The completed form must be maintained in the minor's record with the prescriber.




